Key Work Packages (1)

WP2. Development of interdisciplinary Energy and Environmental Law curricula for master students

- a) detailed needs assessment and planning of curricula and their placement for each university and its discussion among all the partners (at the Kickoff Meeting) and appointment of academic teams;
- b) knowledge transfer form EU (sharing and adapting curricula from EU partners, discussions, peer reviews, quality control, support to develop lecture books, guest lectures, support to development of processes), where all EU partners are involved.

Results: Curricula + Lecture Books for 5 Master modules / 3-5 courses per module for all PCUs and other partners, based on European standards and adapted to local needs.

Key Work Packages (2)

WP3. Development of interdisciplinary Energy and Environmental Law curricula for doctoral students

The aim of this WP is to develop tailor made curricula for PhD in Energy and Environmental Law for 6 partner universities and 1 research institute in Ukraine and Georgia, in order to support a systematic approach to education and research in this very important topic. The development of the curricula will be based on knowledge transfer from EU partners, thus enabling development of European up-to-date curricula, in accordance with all current standards, including the Bologna process.

Results: Curricula + Lecture Books for 3 PhD modules / 3 courses per module for all PCUs and other partners, based on European standards and adapted to local needs.

WP4. Capacity building for PC tutors

The main goal of this WP is to support capacity development at the partner universities and institutions by offering tailor made trainings. It will support

- a) the academic staff in developing the curricula for Master and PhD programs (through tailor made trainings which support curriculum development),
- b) staff of the consultancy bureaus (through tailor made trainings for this staff) and
- c) staff of non-academic partners which will take part at some of these trainings.

Target groups (professors developing courses, staff of consultancy bureau, non-academic partners and several representatives of university management) will go to 1 week study visits to EU partner institutions.

Key Work Packages (4)

WP5. Establishment of two consultancy bureaus of Energy and Environmental Law

The functions of each bureau include the training activities for wide target groups (MSc and PhD students, administrative R&D staff at partner universities and market customers):

- 1) Training of master and doctoral students of different PCU with developed Master modules program via FirstClass elearning system;
- 2) Providing in-service training sessions and workshops "on demand". The lecturers from NULAU and Academy of Law Sciences (Ukraine) and Ilia State University will be invited to carry out the training event for the specified group of external participants needed in such seminars;
- 3) Providing consulting activities for the companies and individuals in the area of Energy Law management.
